## Objetivos

### Objectives

This call aims to support skills development and training initiatives in the context of the LIFE Clean Energy Transition sub-programme. Its main objective is to enhance workforce capacities for the clean energy transition, targeting professionals and organizations engaged in energy efficiency, renewable energy, and sustainable construction sectors across eligible EU Member States. Eligible entities typically include public or private organizations, research institutions, and training providers capable of delivering high-impact skills and capacity-building projects contributing to climate objectives.

## **Funding**

Funding under this call is in the form of non-refundable grants. The co-financing rate can reach up to 95% for eligible project costs, depending on the type of activity and applicant. The maximum grant contribution per project is 1.500.000€ and will depend on the project scope and relevance to the specific themes. Budgets should be commensurate with the scale and ambition of the proposed work plan.
