Obiettivi

Objectives

This call aims to support innovative projects within the LIFE Programme to facilitate the transition towards a sustainable, circular, energy-efficient, and climate-resilient economy. The objective is to contribute to a toxic-free environment and protect, restore, and improve environmental quality in line with the European Green Deal. Eligible applicants include public, non-governmental, and private entities from any sector within eligible European countries. Priority themes include Circular Economy and Waste, Zero Pollution and Sustainable Management of Natural Resources, and Environmental Governance. Projects must address specific topics such as recovery of resources from waste, implementation of circular business models, reduction of hazardous substances, reduction of single-use products, water resilience, air quality improvements, and sustainable management of natural resources.

Funding

Selected projects are eligible for co-financing rates up to 60% of eligible costs. The minimum and maximum budget amounts can range from 2.000.000€ to 10.000.000€ and will depend on the project scope and relevance to the specific themes. Proposals should be innovative, cost-effective, and scalable for EU-wide replication, demonstrating clear environmental impact within the project period.
