Obiettivi

Objectives

This incentive under the LIFE Programme targets Climate Change Mitigation via Standard Action Projects (SAPs). Eligible applicants include public, non-governmental, and private sector entities across the EU. The main objectives are to develop, demonstrate, and promote innovative techniques and approaches for climate action, contribute to the knowledge base, support the implementation of EU climate legislation, and catalyse wide deployment and market uptake of new solutions. Projects must address one of the following intervention areas: recovery and recycling of ozone-depleting substances and fluorinated gases, fostering zero-emission mobility, decarbonising transport modes, boosting renewable energy generation and energy efficiency, reducing GHG emissions in industry and waste, advancing land and coastal management for carbon sinks, and the implementation of robust climate-friendly practices in agriculture and forestry.

Funding

Funding is provided as a non-refundable grant, with a co-financing rate of up to 60% of eligible costs. The call supports demonstration and close-to-market projects, encouraging significant replication and market impact. The minimum and maximum budget amounts can range from 1.000.000€ to 5.000.000€ and will depend on the project scope and relevance to the specific themes. Special consideration is given to proposals leveraging additional public or private investments and demonstrating robust business and sustainability models.
