## Objectives

### Objectives

This call, LIFE-2026-CET-BETTERRENO, aims to support the Clean Energy Transition under the LIFE Programme, focusing on actions that facilitate the renovation of existing buildings for improved energy performance. Eligible participants include consortia of entities such as private companies, public bodies, research institutions, and non-profit organizations based in EU member states or associated countries. The call seeks to foster innovative business models, technical solutions, and collaborative approaches for large-scale energy renovation of the building stock.

### Funding

Funding under this call is in the form of non-refundable grants. The co-financing rate can reach up to 95% for eligible project costs, depending on the type of activity and applicant. The maximum grant contribution per project is 2.000.000€ and will depend on the project scope and relevance to the specific themes. Budgets should be commensurate with the scale and ambition of the proposed work plan.
