Objectives

Objectives

This incentive is part of the LIFE Clean Energy Transition sub-programme and aims to support actions facilitating the transition to sustainable, energy-efficient communities and economies in Europe. Eligible applicants typically include public and private legal entities, such as small and medium-sized enterprises, non-profit organizations, local and regional authorities, as well as research institutions, active in energy transition and environmental sustainability. The main objective is to foster innovation and implementation of solutions that promote energy efficiency, renewable energy integration, and encourage the reduction of greenhouse gas emissions.

Funding

Funding under this call is in the form of non-refundable grants. The co-financing rate can reach up to 95% for eligible project costs, depending on the type of activity and applicant. The maximum grant contribution per project is 1.750.000€ and will depend on the project scope and relevance to the specific themes. Budgets should be commensurate with the scale and ambition of the proposed work plan.
