Objectives

Objectives

Projects are expected to improve the competitiveness and resilience of freight transport and logistics systems by optimising multimodal operations and strengthening supply chains. They should enhance efficiency, flexibility, and reliability of transport networks, while supporting the integration of different transport modes and improving overall system performance.

Scope

The action focuses on demonstrating innovative solutions for multimodal freight transport and logistics, including digital tools, data-driven approaches, and system integration. Projects should address challenges such as coordination across transport modes, real-time information sharing, and disruption management, while improving sustainability and operational efficiency.

Activities are expected to deliver large-scale validation in real conditions, integrating technological, organisational, and business innovations to strengthen supply chains and logistics performance.

Funding

This topic is an Innovation Action with a total budget of around €20 million, expected to fund about three projects of roughly €6.5 million each. Funding can cover up to 70% for for-profit entities and up to 100% for non-profit participants under a lump-sum model.
