Objetivos

Objectives

This call supports collaborative research and development projects aimed at delivering disruptive technologies for the European defence sector. The objective is to foster innovative or radically enhanced defence technologies that can bring about paradigm shifts in defence operations and capabilities. Targeted beneficiaries include consortia of legal entities (public or private) established in EU Member States or EDF-associated countries, particularly those with expertise in artificial intelligence, quantum technologies, autonomous systems, robotics, and advanced materials. Entities must demonstrate potential for a disruptive effect within realistic military scenarios, and all proposals must clearly align with at least one key defence domain and present a compelling technological vision.

Funding

The total available budget for this call is EUR 27,000,000. Project grant requests must not exceed EUR 3,000,000, with reimbursement of eligible project costs at a funding rate of 100% via lump sum grants. Projects are expected to last between 12 and 24 months, with a possibility for longer duration in justified cases. Support to third parties is permitted under specific conditions. Only depreciation costs for equipment are eligible under this call.
