Objetivos

Objectives

This call aims to advance innovative SMEs in transforming technological and research results into defence products in a rapid and cost-effective manner. The objective is to support collaborative development activities for defence, including adaptation of civil-originated technologies to defence needs and fostering cross-border integration of European SMEs. Eligible entities are strictly small and medium-sized enterprises (SMEs) from at least three different

eligible countries (EU Member States or associated countries), with all consortium partners required to have SME status and be registered as such. The call covers a broad range of innovative defence solutions and technologies that enhance readiness, reliability, safety, and sustainability in defence operations, infrastructure, energy, or digital domains, prioritizing development applications from technology readiness level (TRL) 4 and above.

Funding

The total available budget for this call is EUR 30,000,000 with no fixed maximum number of supported projects. The maximum EU grant per project is capped at EUR 6,000,000. Funding rates vary by activity type and may include bonuses for consortia integrating cross-border cooperation, SMEs, or mid-caps, with the maximum funding rate reaching up to 100% for studies and certain development actions. Proposals must include co-financing for action costs not covered by the EDF grant.

Bónus e Majorações

- PESCO bonus: +10% if project is developed under permanent structured cooperation
- SME bonus (non-cross-border): Up to +5% if e10% costs allocated to SMEs in same country as non-SME beneficiaries
- SME bonus (cross-border): Up to double the % of costs allocated to SMEs from other eligible countries
- Mid-cap bonus: +10% if e15% costs allocated to mid-cap enterprises
