Objetivos

Objectives

This incentive, under the LIFE programme, aims to support projects that empower energy consumers for the clean energy transition. Eligible applicants include public and private entities, such as energy agencies, consumer associations, municipalities, and businesses committed to facilitating energy efficiency, renewable energy uptake, and greater consumer engagement in Europe's clean energy transformation. Projects should address the challenge of citizen and end-user involvement in sustainable energy practices and promote innovative solutions as part of the EU's efforts to achieve climate neutrality.

Funding

Funding under this call is in the form of non-refundable grants. The co-financing rate can reach up to 95% for eligible project costs, depending on the type of activity and applicant. The maximum grant contribution per project is 6.000.000€ and will depend on the project scope and relevance to the specific themes. Budgets should be commensurate with the scale and ambition of the proposed work plan.
