Objetivos

Objectives

projects are expected to improve the understanding of the factors affecting renovation rates in affordable rental housing and support policymakers in revising policies, regulations, and business models. They should enable increased renovation uptake while maintaining affordability, particularly for vulnerable and low-income households, and contribute to aligning housing policies with decarbonisation goals.

Scope

The action focuses on analysing and improving policy frameworks and business models for affordable and sustainable housing renovation. Projects must assess the effectiveness of existing policies and support instruments across different governance levels, develop methods to compare affordability across markets and population groups, and design new or improved solutions that balance cost, energy efficiency, and climate objectives.

Activities should include validation of these solutions in real contexts, considering different building types, ownership models, and geographic conditions, while addressing energy poverty and supporting the objectives of the Renovation Wave and the Built4People partnership.

Funding

This topic is a Research and Innovation Action with a total budget of around €15 million, funding a small number of projects (around €5 million each). Funding can cover up to 100% of eligible costs for all participants under a lump-sum model.
